A New GCU Celebration



From the day it was founded, GCU honored its patron saint by celebrating his feast on December 6th. However, May 9th is observed in our Byzantine liturgical calendar as the "Translation of the Relics of Saint Nicholas the Wonderworker from Myra to Bari." This commemoration was established in the life of the church when on May 9, 1087, the relics of Saint Nicholas were solemnly transported into the church of Saint Stephen, not far from the sea in Bari, Italy.

On Sunday May 5th, GCU members and faithful gath-

ered at St. Nicholas Chapel adjacent to the GCU's Home Office to honor our patron saint. This initial Spring St. Nicholas Day celebration was extra special as the replica of the Krasny Brod (Красный Брід) Icon of our Lady was also blessed

The GCU's 2024 First Quarter Financial Report by our Chief Financial Officer, Tim Demetres is presented on page 4 for your review. We experienced continued asset growth as assets increased \$30.7 million totaling \$2.735 billion. Surplus declined by \$3 million primarily due to an asset valuation reserve adjustment of \$4.8 million as this required reserve provides capital for unexpected credit losses. A net income loss of \$1.3 million was also experienced due to the current high interest rate environment as GCU increased annuity crediting rates to remain competitive in the Fixed Rate Deferred and Fixed Indexed Annuity marketplace. Despite the current challenges facing many financial institutions, GCU continues to maintain a strong financial position. Our sincere thank you and appreciation for your continued support and trust in placing your life and annuity business with us!

In closing, my best wishes to you and your family for a safe, relaxing and fun-filled summer! Enjoy the beautiful and colorful summer landscape that God provides.

First Quarter 2024 Financials



apital markets breathed a sigh of relief when the Federal Reserve announced it was pausing the raising of interest rates in the latter part of 2023. The rapid rise in short-term interest rates disrupted the financial markets and affected the life insurance industry. GCU is transitioning to this possible "new norm" with interest rates remaining higher for longer. As we increase annuity crediting rates, a positive benefit for our members, operating earnings will be challenged in the short term. Notwithstanding the high level of market volatility, GCU maintained its financial strength by growing total adjusted capital in a challenging environment. Our members trust GCU to be a Safe, Se-

cure, and Stable community-based fraternal organization.
Highlights for the first quarter 2024 financial results are as follows:

GCU's total assets increased \$31 million to \$2.74 billion and surplus decreased \$3 million as of March 31, 2024 compared to December 31, 2023 mainly due to increasing the asset valuation reserve by \$5 million.

Income (loss) before net realized capital gains (losses) totaled (\$1.50) million for the first quarter 2024 compared to \$1.7 million reported in 2023. The net loss for the first quarter was primarily due to increasing annuity crediting rates and lower net investment income from outflows on annuity products. Net income (loss) after realized capital gains (losses) was (\$1.3) million in 2024 compared to \$2.0 million in 2023. Net realized gains was \$145 thousand in

2024 compared to \$258 thousand in 2023.

Total Assets ended the first quarter at \$2.74 billion compared to \$2.70 billion at the end of 2023. The change reflects increases in bonds, alternative assets, and derivative assets.

Liabilities grew relative to new life and annuity sales, net of outflows from surrender activity and totaled \$2.52 billion at March 31, 2024 compared to \$2.48 billion at yearend 2023. The \$34 million increase in total liabilities is due primarily to a \$29.2 million increase in life and annuity reserves and a \$4.8 million increase in AVR.

Total Income decreased \$8.4 million to \$119.6 million in the first quarter compared to \$128.0 million in 2023. Annuity new business sales decreased \$12.9 million. We experienced an increase in conversion activity, with members electing to convert their out-of-surrender contracts for new contracts that can grow in value faster from higher crediting rates. Net investment income increased to \$29.6 million.

Operating expenses, before the increase in reserves, totaled \$92.4 million versus \$100.6 million in 2023, a decrease of \$8.2 million or -8%. GCU disbursed \$11.2 million less in annuity benefits for death claims, full and partial surrenders compared to the prior year. Annuity exchanges increased \$4.1 million. General insurance expenses were \$412 thousand lower in 2024 when compared to 2023 primarily due to expense saving initiatives and the timing of when certain expenses are incurred.

The change in reserves totaled \$28.6 million in 2024 compared to \$25.6 million in 2023. Reserve changes are a function of premiums received, death claims, annuity benefits paid and interest accumulation.

Surplus at March 31, 2024 decreased \$3 million to \$218 million from \$221 million year-end. The net decrease in

surplus reflects an increase in net unrealized gains offset by the reduction for the net loss in the period and an increase to the asset valuation reserve.

Total Adjusted Capital (TAC), a risk metric used by regulators and rating agencies, increased \$2 million to \$251.1 million as of March 31, 2024, from \$249.4 million at December 31, 2023. TAC starts with surplus of \$218.3 million

and adds back the asset valuation reserve of \$32.6 million and one-half the dividend liability of \$150,000. The solvency ratios based on TAC was unchanged at 110.1% as of March 31, 2024. This ratio reflects GCU's consistency in financial strength.

Happy Birthday!

hen the Day of Pentecost had fully come, they were all with one accord in one place. And suddenly there came a sound from heaven, as of a rushing mighty wind, and filled the whole house where they were sitting. Then there ap-

peared to them divided tongues, as of fire, and one sat upon each of them. And they were all filled with the Holy Spirit and began to speak with other tongues, as the Spirit gave them utterance.

Acts 2:1-4

Dear Friends,

Glory to Jesus Christ!

As I write this article, we are preparing to celebrate Pentecost Sunday. This major feast is known as the feast of the Descent of the Holy Spirit, Trinity Sunday, or the Green Holiday. In the "old country" this feast day is also called Русадля or Rusal'a. These last two titles have a pre-Christian origin amongst the Slavs.

What took place in the upper room in Jerusalem is also the celebration of the "beginning." What beginning? The "birthday" of the Church as the presence among us of the Holy Spirit, of the new life in Christ, of grace, knowledge, adoption to God and holiness.

Friends, from its "beginning" in 1892 our GCU was always associated with our Byzantine Catholic Church. GCU lodges were born in Church halls and the GCU continues to be active in Byzantine Catholic Churches nationwide.

This year is significant for us as we will celebrate the centennial of the establishment of the Byzantine Ruthenian Catholic Church Exarchate in the United States (1924) and the golden anniversary of the dedication/consecration of the Byzantine Ruthenian Chapel at the Basilica in Washington, DC. (1974). Since then, our Byzantine Ruthenian Catholic Church in the United States has been dedicated to the Protection-Pokrov of the Mother of God.

Yes, a lot of time has passed since these significant events in the life of our Church. However, they are still very important for us as we look towards the future of the Church, especially since "You have to know the past to understand the present" (*Carl Sagan*).

But where do you and I stand in relationship to the "Church"? How important is it to you, my friend? I recall

one day when one of our daughters came home from school and I asked one of them: "So what did you learn today?" My daughter goes "Here is the church, and here is the steeple, open the door and see all the people." And that of course was accompanied by her little fingers. This happened 20 years ago!

The Church is you and me, the people of God. The Church, or rather the Church of the faithful, embodies the Christian faith, projects Christian hope, and gives life to Christian love. In my previous parish assignment, we had a new Church sign built and underneath that sign it said, "All Are Welcome." Believe it or not I did receive a few comments like: "Why are ALL welcome Fr. Val?" We the faithful, whether we are saints or sinners, we assemble together under the Church's shelter to achieve repentance and forgiveness. Our Lord continues to call ALL of us: "Come to me, all you who are weary and burdened, and I will give you rest. Take my yoke upon you and learn from me, for I am gentle and humble in heart, and you will find rest for your souls. For my yoke is easy and my burden is light." (Matthew 11:28-30) From that first Pentecost in Jerusalem, in this Church, the truth is preserved, proclaimed, and shared sacredly among ALL the faithful.

As you read this article you might say "But what about my Church? The attendance is low, we have trouble paying the bills, we have no younger families/children in the parish, etc. Yes, we do have reasons to be discouraged. The statistics are gloomy. It's easy for us to fall into decline narratives—believing things will only get worse. They can and probably will. Let's be honest, our historical Byzantine Catholic Churches are not in areas that have booming economies.

Still, Our Lord continues to teach us: "For where two or three are gathered together in my name, there am I in the midst of them." (Matthew 18:20) Even though our attendance may be low in a number of our Churches, we can still live the life of the Church to which we are called. But how?

Let our Byzantine Catholic Churches continue to provide a sense of belonging. Being part of a Church gives you a sense of belonging and acceptance, which can be difficult to find elsewhere. That is something our parishes and GCU always provided for our faithful. The sense of belonging is essential for us to survive.

Let our Byzantine Catholic Churches continue to foster

relationships. Especially in our smaller communities we can foster meaningful relationships and friendships that can last a lifetime. Sharing with someone in your parish your interests, passions and even struggles.

Let our Byzantine Catholic Churches continue to promote a ministry of service to our faithful and to the wider community. Even in our smaller communities working together with the GCU we can provide outreach programs, charity events and opportunities to serve others.

Let our Byzantine Catholic Churches continue to offer support and personal growth. Our Divine Liturgy and Divine Services are celebrated to bring you into communion with God. Our spiritual expression provides many Divine Services which are cycles of prayers for the day, the week and the year, commemorating various events in the lives of Jesus Christ and His Saints. Personal growth can also be achieved in our parishes through prayer groups, Bible studies, presentations and other programs that can help you deepen your faith, strengthen your character and grow as a person.

Friends, writing this article I recognize the hardships our "Church" is going through in the 21st century. When the GCU was established in 1892 the founders also recognized the hardships our faithful were facing in their lives. These were humble beginnings, but they took action! I might even add that they were inspired by the Holy Spirit.

As we celebrate Pentecost Sunday, the birthday of the Church, let us remember that the Holy Spirit vivifies the Church, impels it to carry out its mission and unifies it in love. Before you take action in your Church - in your parish, remember my friend to offer that beautiful prayer to the Holy Spirit:

Heavenly King, Comforter, Spirit of Truth
You are everywhere present and fill all things.
Treasury of blessings and Giver of Life,
Come and dwell within in us,
Cleanse us of all stain,
And save our souls O Gracious One.

The legacy of our Byzantine Catholic Church and the GCU, if anything, teaches us that humble beginnings with prayer, perseverance and action can help us overcome challenges and keep us moving forward. As we will celebrate this year's historical milestones of our Byzantine Catholic Metropolitan Church, let us call upon the Holy Spirit to inspire and guide our hierarchy, clergy, monastics-religious and beloved faithful for the benefit of the whole Church.





Lessons in the Law

Who Should Be My Executor?

his is the question I often am asked. Who should be my executor? In most cases, if you are married you pick your spouse. If you are not married, usually you pick one of your children or a close friend.

One mom told me she has three children and then proceeded to tell me one child is in jail for theft, one child has filed bankruptcy two times and the third child lives out of the country and comes home for his Christmas present. Whom should she pick she asks me. I told her this is a case where she needs to ask one of her good friends to be the executor.

This is a common problem and you need to choose the right person or will have a disaster on your hands when the executor takes all the money.

What if you don't have a family member or friend you trust? What do you do? In some cases, your accountant, your attorney or even your bank can act as your executor.

If you choose an executor and the executor does not qualify to be the executor, then you can find that the probate court will appoint an administrator and the estate will incur additional bond fees in addition to the administrator fees.

If you have substantial assets or minor children, you may have to create a trust to avoid probate court and the bond costs. Again, trusts may be expensive to create, but the trust could save you thousands of dollars.

It is very important that you don't make these decisions without proper advice from an attorney experienced in these issues.
